#### **Dynamex** Applied Retroactively

The Ninth Circuit decided *Vazquez v. Jan-Pro Franchising International, Inc.*, a putative wage and hour class action. In *Vazquez*, the Ninth Circuit analyzed whether Jan-Pro's franchisees were in fact employees, as opposed to independent contractors. The Ninth Circuit held that the California Supreme Court's intervening decision in *Dynamex v. Superior Court* is controlling and applies retroactively.

In *Dynamex*, the California Supreme Court clarified that the standard presumption in California is that all workers are employees, rather than independent contractors. The Court also ruled that the burden of establishing the proper classification of an individual as an independent contractor falls on the hiring entity, pursuant to the ABC test that requires the hiring entity to establish that: (A) the worker is free from the control of the hiring entity; (B) the worker performs work outside the hiring entity's usual business; and (C) the worker is customarily engaged in an independent business of the same nature as the work performed.

Because the California Supreme Court merely clarified existing California law in *Dynamex*, as opposed to creating new law, the Ninth Circuit in *Vazquez* concluded that *Dynamex* must be applied retroactively and therefore remanded to the district court to consider the merits of the case in light of *Dynamex*.
